Report on California fire service representatives appointed to NFPA professional qualification standards committee as requested by the SBFS at the November 21, 2013 meeting

Background Information:

During the November 21, 2013 the SBFS received a Curriculum Development Task Force Update from Bill Vandevort, Fire Service Training Specialist III. During discussion on this topic SBFS members asked if staff knew the status of California fire service representatives appointed to NFPA professional qualifications committees.

Analysis/Summary of Issue:

Chief Hoover subsequently received a report from NFPA containing the names of all individuals who reside in California and are appointed to NFPA committees. Staff has reviewed this report and has prepared the attached table which lists California fire service representatives appointed to NFPA professional qualifications committees.

There are fourteen (14) NFPA professional qualifications committees. In addition to Chief Hoover's appointment to the Professional Qualifications Correlating Committee, there is at least one (1) California Fire Service representative on twelve (12) of the fourteen (14) committees. Four (4) of the twelve (12) committees have two (2) or more representatives participating. Three (3) committee members are also members of STEAC; one (1) committee member has participated on a current curriculum development cadre; two (2) committee members have participated in past curriculum development projects. The two (2) committees which do not have California fire service representation are NFPA 1041-Standard for Fire Service Instructor Professional Qualifications and NFPA 1051- Standard for Wildland Fire Fighter Professional Qualifications.
