Fireworks Program Update

### RECOMMENDED ACTIONS:

This is information only. The purpose of this report is to update the board on program activities, goals, and direction.

### BACKGROUND INFORMATION:

The Fireworks Program is one of The Office of The State Fire Marshal's original core programs.

The program provides fireworks and pyrotechnic licensing, supports other agencies throughout the state in statutory, regulatory, permitting, technical expertise, and enforcement services. The program utilizing only three personnel (two located in Sacramento and one in Southern California).

With recent management and industry changes, the program's responsibility has continued to expand rapidly. The Fireworks Program anticipates adding an additional person in early 2016 to address program demands.

### ANALYSIS/SUMMARY OF ISSUE:

#### I. Seizure and Disposal

Pounds of fireworks for destruction are based on amounts reported on seizure report forms and are considered *estimated*. Pounds of fireworks shipped were actually weighed.

Fireworks reported seized left over from previous years	226,000 lbs.
Fireworks reported seized since January 2015	56,728 lbs.
Fireworks currently held in SFM storage	20,000 lbs.(included in previous years)
Viable fireworks held at Magazine Canyon	15,600 lbs.(already processed)
Viable fireworks held at Victorville	25,800 lbs.(already processed)
Fireworks shipped/destroyed since July 1, 2015	77,000 lbs.
Remaining fireworks to process	164,328 lbs.

## II. Regulations

- The Division has hired an AGPA to assist with regulations packages. The AGPA will start November 1, 2015.
- CCR, T-19, Chapter 6 will be completely revamped. This is the new AGPA's first priority.
- Program is currently working to implement a new General Fireworks committee pending approval of interested member candidates by Chief Hoover.
- Highlights include:
  - Possible Fee increases.
  - Updating and codification of applications and process.
  - Instituting tiered application and background investigation of operators.
  - Clarification of classification, storage, and use of fireworks and pyrotechnics.
  - Regulations for the fireworks stewardship program should the program be signed into law.

## III. Licensing

Program currently provides licensing services for 1,546 fireworks and pyrotechnic licensees in 24 separate categories.
