State Fire Training is pleased to announce the update of **Fire Prevention 1A, Introduction To The California Fire Code** and **Fire Prevention 1B, Inspection of Fire Protection Systems and Special Hazards**. We would like to thank Howard Cooke (Sacramento Fire Department), Keith Marshall (Burlingame Fire Department retired), Robert Marshall (Gilroy Fire Department), and Rocque Yballa (Central County Fire Department) for their commitment to complete this project.

**October 1, 2008** is the designated start date for delivering the updated courses. It is required that you use the new curriculum and certification exam for courses delivered on or after this date.

The 2008 Fire Prevention 1A and 1B Instructor Guides have been updated to reflect current CFC requirements. Both courses still use parallel textbooks and a student supplement. The textbooks required are the **2007** edition of the California Fire Code (CFC) published by the California Building Standards Commission (CBSC) and the **sixth** edition of IFSTA's Fire Inspection and Code Enforcement. The student supplement is published by State Fire Training. All certification exam questions are from the California Fire Code, Fire Inspection and Code Enforcement, or the student supplement. Students may use the California Fire Code when taking the certification exam. No other texts or notes are allowed.

The instructor guide, student supplement, and slides are now available for purchase through State Fire Training's Bookstore. An order form is attached for your use.
