



# IMPLEMENTATION PLAN

## NWCG, FEMA, and SFT Course Adoptions, Updates, and Retirements

Issued: December 2020

### OVERVIEW

State Fire Training (SFT) manages curriculum and provides course completion diplomas for 162 courses. SFT identified discrepancies between the SFT website, Procedures Manual, and the Course Information and Required Materials Manual (CIRM). Several courses are now retired or have not been delivered since 2015. This Implementation Plan provides updates, retirements, and new recommendations from the Steering Committee to update and adopt select NWCG Courses.

### CURRICULUM IMPLEMENTATION

SFT recognizes that many SFT Instructors, Accredited Academies, Agencies, and stakeholders are invested in the current curriculum. The current curriculum and instructor requirements will apply to courses hosted during the transition period.

## **INSTRUCTOR REQUIREMENTS**

### **Instructor Registration ..... Available December 17, 2020**

Instructors may register for the new courses using either the retiring course diploma or the new course diploma until July 1, 2021. After that date, instructors seeking registration must complete the updated NWCG or FEMA-NIMS course or apply for a PACE 2 (Instructor Reciprocity) review of their instructor qualifications, including appropriate education and practical experience relating to course content.

### **Existing Registered Instructors**

Instructors currently registered and in good standing for any of the retiring NWCG or FEMA courses will be automatically registered to instruct the updated FEMA-NIMS course.

## **POTENTIAL AGENCY IMPACTS**

Accredited Regional Training Programs (ARTP), Accredited Local Academies (ALA), community colleges, and all other local delivery venues need to review the curriculum and seek approval from their curriculum committee/program sponsor, as appropriate. ARTPs should review the new curriculum and discuss potential impacts with their advisory committees.
