FDID Information Change Notice: Fill this out and submit when there is a change in contact information, Fire Chief, or if your FDID is consolidating with another FDID. To view the current information we have on file, click **FDID List**

FDID List: A list of every department in the state. Use to locate FDIDs that need to be entered when filling out an Aid Given report

Incident Code Guide: Easy to read list of all incident types with short descriptions

Using the Quarterly Report

We post an updated [Quarterly Report](#) after each quarter that shows every department's reporting history since 2010. This can report can be used to:

- Provide verification to FEMA that your department's NFIRS reporting is up to date
- Identify if you missed submitting data for any quarter
- See the percentage and count of invalid incidents for your department
- Confirm that our database numbers match your department's data

Scroll down or use ctrl+f to locate your FDID. Note that your department is named at the bottom with the totals.

Each quarter is separated into Valid and Invalid incident columns

Grand totals are listed at the bottom; yearly totals are shown in the same row as the year

Remember: The report is posted quarterly. The data may not match what you sent if you submitted a file after the report was posted. Check the date on the bottom of the page.
